CONDITIONS AND GENERAL POLICIES

DATA PROTECTION POLICY

At Legendary Peru, we respect the privacy of our customers, suppliers, travel agencies, and other individuals with whom we have a business relationship. We are committed to processing personal data responsibly, confidentially, and in accordance with Law No. 29733—the Personal Data Protection Act—its Regulations, and other applicable regulations.

Data Controller

Legendary Peru is the data controller responsible for processing the personal data provided to us during the request, reservation, organization, and provision of tourism services.

Personal Data We Collect

We may collect, among other things, the following information:

- First and last names.
- Nationality.
- Date of birth.
- Passport or ID number.
- Contact information (email, phone number, and address).
- Flight and itinerary details.
- Information necessary for reservations for hotels, transportation, trains, flights, excursions, and other tourism services.
- Information related to dietary preferences, allergies, special requirements, or travel restrictions that the customer chooses to voluntarily disclose for the proper provision of services.

Purpose of Processing

Personal data will be used to:

- Manage quotes, reservations, and the provision of tourism services.
- Coordinate services with hotels, airlines, local operators, transportation companies, restaurants, travel insurance providers, and other suppliers involved in the itinerary.
- Contact the passenger before, during, and after the trip when necessary.
- Comply with legal, immigration, tax, or administrative obligations.
- Address inquiries, requests, complaints, or emergencies during the trip.
- Improve the quality of our services.

Shared Data

Personal data may be shared only with providers involved in the provision of the contracted services, such as hotels, airlines, rail companies, tour operators, transportation companies, insurance providers, restaurants, competent authorities, or other providers essential to the proper execution of the trip.

Legendary Peru does not sell or transfer personal data to third parties for purposes other than those necessary for the provision of the contracted services, except where required by law or with the data subject's express authorization.

Data Retention

Personal data will be retained for as long as necessary to fulfill the purposes for which it was collected and for the periods required by applicable law.

Information Security

Legendary Peru takes reasonable technical, organizational, and administrative measures to protect personal data against loss, unauthorized access, alteration, disclosure, or improper processing.

Data Subject Rights

The data subject may exercise the rights of access, rectification, updating, erasure, objection, and other rights recognized by Peruvian law by submitting a request to Legendary Peru through the customer service channels provided by the company.

Consent

By providing their personal data and contracting our services, the customer declares that they have read this Personal Data Protection and Processing Policy and authorizes Legendary Peru to process such information for the purposes described, to the extent necessary for the proper provision of the contracted tourism services. Legendary Peru will process all information received under strict standards of confidentiality, professionalism, and security.
